Causeway open to all Monday & Tuesday

The City of Sanibel has reviewed debris removal on the island and determined that residents and contractors will be able to access the Causeway on Monday and Tuesday, Oct. 31-Nov. 1. Originally, the plan was to limit access to emergency contractors only to facilitate cleanup.

The city will evaluate access weekly as debris removal continues. A curfew continues on both islands from 9 pm to 6 am, and anyone accessing the Causeway after 9 pm will be questioned.

Also, the city has restored the normal speed limits, removing the 20 mph limit that had been in place since the Causeway reopened. Drivers are cautioned to watch out for work crews and trucks, and to slow down as conditions warrant.

Finally, City Attorney John Agnew provided an update on the revised property appraisals just completed by the Lee County Property Appraiser's Office, which may impact those properties facing rebuilding issues due to FEMA's 50% rule. Check out the Oct. 28 city Facebook update at

Manatee protection zones to be reviewed

The Lee County Board of County Commissioners will conduct a Public Hearing on Tuesday, Nov. 1, to adopt an ordinance pertaining to manatee protection and slow speed zones applicable to Captiva Island (bayside including Roosevelt Channel), North Captiva (Safety Harbor), and Gasparilla Island (Boca Grande Bayou) and seek approval of the ordinance from FWC.

Based upon the best available scientific information, manatees inhabit the bayside areas along Captiva Island (quarter-mile buffer including Roosevelt Channel), North Captiva (Safety Harbor), and Gasparilla Island (Boca Grande Bayou) on a regular basis including winter use. Accordingly, there is a need to post these areas as year-round slow speed zones for manatee protection. Exhibit A of the Draft Ordinance depicts areas proposed to be year-round slow speed zones for manatee protection.

Manatee protection speed zones can be implemented by FWC, or by local government ordinance adoption in compliance with the requirements of Section 379.2431, Florida Statutes. This County ordinance would be subject to approval by FWC, and in accordance with statute, would be reviewed with the best available scientific data.

FWC does not have current plans to review Lee County speed zones. Therefore, Natural Resources Staff compiled and reviewed the best available scientific data including aerial surveys (2007-09), State winter synoptic (one-day) surveys (1991-2019), state carcass recovery data (1975-2019), seagrass maps, and navigation charts. The Draft Ordinance and affected areas can be viewed online at https://www.leegov.com/bocc/meetings/agendas.

The Captiva Community Panel fully supports the adoption of the Manatee Protection Zones Ordinance. For more than two years, the Panel has advocated for the return to the slow speed, minimum wake zone long in existence in bayside areas along Captiva Island prior to Hurricane Irma. The Panel thanks County Staff and the County Attorney for their work on this Ordinance – and especially thanks Stephen Boutelle in Natural Resources/Public Works for his steady commitment to this important matter.

More debris removal trucks arrive in Lee County

FROM LEE COUNTY:

Fifteen additional debris-collection trucks hit the road Oct. 28 to help speed Hurricane Ian recovery. Each collection truck hauls a trailer that doubles its carrying capacity, and each has a grapple for loading.

The new trucks increase the total number of trucks working in Lee County to 125, for a total of 250 debris- collection containers on the road. These trucks are complemented by a fleet of 25 bucket trucks working throughout the county to remove dangerous hanging or leaning trees that pose a public-safety threat. To date, the bucket trucks have removed 479 dangerous trees and more than 9,000 dangerous hanging limbs.

Total storm debris collections now exceed 1.3 million cubic yards – a number that includes vegetative waste, construction and demolition material, dirty sand and titled property such as boats. Lee County's debris contractor, CrowderGulf, estimates that the first pass to remove hurricane debris in unincorporated Lee County will be completed within the next 30 days.

Each neighborhood will receive at minimum a second pass for debris removal. Additional passes will be conducted as warranted, particularly in those neighborhoods that experienced both wind damage and severe flooding.
